### Board Minutes

March 14, 1999 at the home of Mark Johnson, Minneapolis, Minnesota.

**Present:** Stew Thornley, Rich Arpi., Lee Temanson, Kevin Hennessy, Mark Johnson, Fred Buckland.

The meeting was called to order about 5:30 PM after a tray of sandwiches and a bowl of chips were passed . . . a few times.

**Minutes:** the minutes were distributed in printed form. The correction was noted that **Bob Fanning** should be Bill Fanning.

**Treasurer's Report:** Kevin Hennessy reported that at present their was about an \$820 treasury balance and that there were current 51 members with two paid for the 99-00 year. This does not include, however, any new members picked up since Twins Fest - whose applications may be still in the P.O. Box down at the Loop Station which needs to be checked.

Kevin did express dismay at the difficulty he has in getting to the P.O. Box and suggested we might want to move it to a more central location that has a parking lot.
