Board Minutes of June 6, 2004

Treasurer's Report: Rich report \$ 559.10 in the treasury with no outstanding bills due.

Events: Howard had nothing to report. A new events chair, or Howard's reappointment, will be taken up by the new vice-president.

Quicksteps Vintage Baseball Team: Bob reported two events in May (at St. Olaf and at Dakota Village in Farmington) and two upcoming events in June. On June 13, the nine will engage the staff and spectators at Murphy's Landing and on June 18 (on Friday night) the team will have a game in Brooklyn Park. There was some discussion on what the chapter sponsorship of the Quicksteps really means since several chapter members are members of the St. Croix Base Ball Nine. All of the original Quicksteps were part of the Halsey Hall Chapter but over time several individuals have joined the team but not the chapter. They are encouraged to join the chapter but it has never been a condition for joining the Quicksteps. There has never been a financial relationship between the chapter and the team. The Quicksteps are a chapter activity for those members who wish to participate but membership in the team is not restricted to Halsey Hall Chapter members.
