# SABR Halsey Hall Board Meeting Minutes February 19, 2023 on Zoom

## 1. Review of December 11, 2022 Minutes

Gene will check with Dave Lande and see if he can bring coffee. Gene will send a list of presenters to Howard so Howard can finalize the schedule and Gene will follow up with Howard about doing a PowerPoint presentation for his trivia quiz. Bob will bring his Chromebook and Sarah will bring the tripod and extension cord to stream the meeting on Facebook Live for those who cannot attend. Registration will begin at 8:30 am with the meeting beginning at 8:45 am.

Howard is looking into scheduling a chapter outing to a Wisconsin Rapids Rafters Northwoods League game this summer and he is also organizing a chapter outing to the Gophers baseball game at U.S. Bank Stadium in March.

Stew mentioned that he was in charge of coordinating the last national chapter convention in 2012 and before we commit to anything he suggested we need to get indications from multiple people who would be interested and available to coordinate everything on a local level. Gene asked what it would entail and Stew said it is a daunting task that people need to be aware of before we continue pursuing this. Stew will send Gene a list of chapter members who might be contacted to see if there is interest in taking this on.

Our chapter needs to finalize efforts to achieve All Star or MVP status and the deadline is May 31. On February 22 SABR will hold a chapter leaders meeting and list tools SABR will provide to help chapters reach their goals. Gene and Stew plan on attending the meeting. Bob asked what achieving goals means and Gene explained that there is a checklist of activities that chapters can use as a guide including things like holding meetings and events and membership numbers that some chapters achieve and some do not.
