### 9. MVP Committee Report - Gene Gomes

Registration begins around 8:15 a.m. with the program starting at 8:45. The cost for the meeting and lunch is \$10. People can pay by cash (with correct change appreciated) or check at the door.

The featured guests in the afternoon will be a panel on girls playing baseball instead of softball. Chelsey Falzone, the manager of youth engagement for the Minnesota Twins, will talk about her role with a 14-and-under girls baseball team that the Twins have organized. Some of the players may be there, too. Emma Charlesworth-Seiler, who worked with Chelsey on the 14-U team and helped coach them at a tournament in Reno this year, will also be on the panel.

In addition to being only the eighth woman to umpire in minor league baseball, Emma has played baseball around the world. In 2015 Emma was the recipient of the Jack Kavanagh Memorial Baseball Award for her essay, "Invisible Barriers: Why Baseball Isn't America's National Pastime." The award came with a cash prize and SABR membership as well as a scholarship for Emma to attend the SABR convention in Chicago. That fall, Emma made a presentation on the topic of her paper at the Halsey Hall Chapter meeting.

#### 11. Bylaws and Procedures Review - Ed Edmonds

The By-Laws Amendment will be voted on at the October 25 Fall Meeting's Business Meeting. The board of directors approved a recommendation for an amendment to the chapter by-laws at the last board meeting. The major change is to the structure of the board and officers. If ratified by the membership at the October 25 chapter meeting, each spring the chapter will have a direct election of a president-elect. This person will automatically ascend to president the following year and then to immediate past president, the latter being an ex-officio, non-voting member of the board of directors. Election of a secretary and treasurer will occur every three years. Three directors will serve rotating three-year terms with one director elected by the membership every year.

The proposed method is geared toward getting and keeping valuable experience and getting new people involved while rotating rather than recycling officers and board members. Other details of the plan include a provision that a person completing the president-elect/president/past president cycle could not immediately run for president-elect again. A waiting period would also apply to directors, who would have to wait at least one year to run for director again.

## 12. New Business - Social Studies Conference - Stew Thornley and Mike Haupert

Pillbox Plaque: On Friday, October 3 the Capitol Area Architectural Planning Board approved the application to erect a commemorative marker for the St. Paul Downtown Ballpark (also known as The Pillbox) that was on the corner of 12th and Robert streets from 1903 to 1910. The next step is site selection. Stew Thornley spoke about The Pillbox and the plaque project on October 7 to the Ramsey County Historical Society Gala Fundraiser.
